Beef Quality Assurance trainings to be offered in-person and virtually

University of Minnesota Extension will host Beef Quality Assurance (BQA) trainings both in-person and virtually in the spring of 2025. Producers attending any of the free workshops will receive a three-year BQA certification.

In the past, beef producers have been asked to complete the BQA program to market cattle to certain processors. However, BQA certification is still voluntary. Specific companies have chosen to extend their own quality assurance protocol requirements to cattle producers who are a part of their supply chain. BQA certification is now being required by many major industry buyers and processors.
